ACTION: School Calendar Consultations

Dear District Education Authorities and Commission scolaire francophone du Nunavut Chairpersons and School Principals,

With the passing of amendments to the *Education Act* by the Nunavut Legislative Assembly and its assent on November 10, 2020, changes have been made to the school calendar selection process. Section 83.1. (1) of the updated *Education Act* outlines this process:

Standardized school dates

83.1. (1) The Minister shall, by order, establish three basic school calendars for each school year for each of the Qikiqtaaluk, Kivalliq and Kitikmeot regions, indicating:

- (a) the start and end dates; and
 - (b) the dates of professional development days.

This year, there will be two steps to the calendar call process. The Department of Education is currently working on three basic school calendar options for each region. In mid-February, the department will be providing these proposed school calendar options to DEAs and the CSFN for consultation with your communities.

These consultations are crucial to ensure that you have an opportunity to determine the calendar options that best fit the needs of your students, school staff, and the community.

Once this consultation has concluded and a decision has been reached, the three options for your region will be finalized. At that point, the department will send the



calendar call letter asking you to choose one of the three calendars approved for your region.

DEAs and the CSFN are still required to consult with their community members, school staff, and students on the selection of the school calendar, in accordance with the School Calendar Regulations.
