### NUNAVUT ACTS DESIGNATION POLICY

---

#### **POLICY STATEMENT**

The Government of Nunavut is committed to a government that is fair, transparent, and is reflective of Inuit societal values.

The Nunavut Acts Designation Policy designates departments and ministers responsible for Acts in Nunavut.

#### **PRINCIPLES**

This policy is based on the following principles:

- The Government of Nunavut is committed to being an open, responsive, and accountable government.

#### **APPLICATION**

This policy applies to all departments and agencies of the Government of Nunavut.

#### **DEFINITIONS**

Act: A statute that has received assent from the Legislative Assembly of Nunavut.

List of Act Responsibilities: A comprehensive list of current acts, which designates the lead and support responsibilities for each.

Lead: Is a department or agency of the Government of Nunavut or the Legislative Assembly of Nunavut who has the primary responsibility for an act.

Support: is a department or agency of the Government of Nunavut or the Legislative Assembly of Nunavut who has certain responsibilities under an Act but does not have lead responsibility for the legislation.

#### **ROLES AND RESPONSIBILITIES**

Cabinet will review the designations of all acts at the beginning of each new government and may review them at other times as desired.

Ministers are the legally responsible actors designated under territorial Acts, unless otherwise stated in the Act.

The Department of Executive and Intergovernmental Affairs is responsible for administration of this policy.

The Department of Justice advises on the assignment of act responsibilities.

## **PROVISIONS**

Many acts in Nunavut do not stipulate which minister, department or agency is responsible for their implementation.

In order to support transparency, Cabinet will review and approve the List of Act Responsibilities included in the appendix.

Unless otherwise indicated, the lead is the department or agency as well as the Minister responsible for implementing the act and bringing forward legislative changes.

## **PREROGATIVE OF EXECUTIVE COUNCIL**

Nothing in this directive shall in any way be construed to limit the prerogative of Executive Council to make decisions or take action respecting the assignment of responsibilities for Acts of the Government of Nunavut, outside the provisions of this policy.

## **SUNSET**

This Policy will be effective from the date of approval until December 31, 2021.
