SELF-ISOLATION AGREEMENT

PURPOSE:

- A. The Minister of Health declared a Public Health Emergency in Nunavut effective March 20, 2020 to address the novel coronavirus COVID-19 pandemic. The Minister extended this declaration on April 3, 2020 and April 17, 2020.
- B. In response to this declaration, the Chief Public Health Officer issued an order temporarily restricting travel to Nunavut, effective March 24, 2020, and a revised order effective April 17, 2020. Only Nunavut residents and exempt individuals may enter Nunavut until further notice.
- C. Nunavut residents must complete 14 days of self-isolation (also known as "quarantine") at designated facilities in Ottawa, Winnipeg, Edmonton, and Yellowknife before returning to Nunavut.
- D. Self-isolation does not mean that you have novel coronavirus COVID-19. The purpose of self-isolation is to limit the spread of the virus to Nunavut.

CONDITIONS OF SELF-ISOLATION:

I, ______agree to do the following:

- I will self-isolate for at least fourteen (14) days at ______ (the "isolation facility").
- 2. I will not leave the isolation facility until it is time for me to return home, except as directed by the on-site nurse.
- 3. I acknowledge that I may have to stay at the isolation facility for a period longer than fourteen (14) days due to airline schedules and flight cancellations, and this extension could last up to six (6) additional days.
- 4. I will not leave the isolation facility property when I go outside for fresh air or for a cigarette break.
- 5. I will keep a distance of at least two metres (2 m, or 6 feet) between anyone else and me when I am outside.
- 6. I will not allow visitors to enter the isolation facility or interact with visitors on the isolation facility property during outdoor breaks.

- 7. I will follow the directions of the Chief Public Health Officer.
- 8. During my self-isolation, I will conduct myself in a manner that will not expose others to infection and will take precautions to prevent or limit the direct or indirect transmission of novel coronavirus COVID-19 to others.
- 9. I agree to treat fellow travelers including escort, health-care workers, and isolation facility staff with respect. I acknowledge that if I am abusive (verbally or physically) to others, I may be asked to leave.
- 10.I will refrain from abusing alcohol, cannabis, illegal drugs, or engaging in abusive verbal and/or physical behaviour, violent behaviour or illegal behaviour, including behaviour that results in harm to individuals and/or property damage. I acknowledge that there is zero tolerance for illegal drug use, and illegal or abusive behaviour.
- 11.I will abide by the rules of the isolation facility, including the rules respecting smoking (tobacco or cannabis) and vaping indoors.
- 12.I understand that I may be invoiced for any damages resulting from intoxication, abusive, violent or illegal behaviour, or smoking or vaping indoors.
- 13.I acknowledge that if I do not follow the self-isolation measures in this agreement, the Government of Nunavut will cease providing funding support to cover accommodations at the designated isolation facility, and I will be asked to leave.
- 14.I acknowledge that I will not be permitted to return to Nunavut until I complete fourteen (14) days of isolation at the isolation facility.
- 15.I acknowledge that if I do not follow the isolation measures in this agreement, I may become subject to an order under the public health legislation in the applicable province or territory.
