

COVID-19 GN Update

January 20, 2022

Premier's update:

Ullakkut,

As of this morning Nunavut has 175 positive cases of COVID-19.

We have active cases in 19 communities – the reported numbers are:

- 35 in Arviat,
- 35 in Baker Lake,
- 16 in Cambridge Bay,
- One in Chesterfield Inlet,
- Four in Coral Harbour,
- Zero in Igloolik
- 16 in Iqaluit,
- One in Gjoa Haven,
- 14 in Kinngait,
- Zero in Kugaaruk,
- 12 in Naujaat,
- Zero in Pangnirtung,
- Zero in Pond Inlet,
- One in Qikiqtarjuaq,
- 17 in Rankin Inlet,
- Four in Sanirajak,
- 11 in Sanikiluaq,
- Five in Taloyoak, and
- Three in Whale Cove.

We have 50 reported recoveries today. There have been 428 total reported recoveries in this outbreak.

Minister of Health Update:

Good Morning.

I'd like to speak about how important vaccines are in the fight against COVID-19.

By now, you've all heard the experts – like Dr Patterson, and other respected health professionals – urge people to get vaccinated against COVID-19. Ask yourself - how many times have you heard this message: 'Get vaccinated'. And ask yourself: why do our experts keep repeating it?



They share this message, and they repeat this message, because it's true. Despite Omicron being a new variant, and being more contagious, their advice is still critically important. These are the facts. The COVID-19 vaccines still hold great benefit for those who roll up their sleeves. Vaccines still help keep our families, friends, and coworkers safe.

Despite the repeated messaging, I'm concerned that still too many Nunavummiut aren't vaccinated, or are only partially vaccinated. And so today I'd like to appeal to the families and friends of those people. If you know someone who needs a vaccine – please, speak to them, listen to their concerns. Help them to access reliable information about vaccines. Help them to book an appointment. I know opinions on vaccines can be strong, and it can be frustrating at times, but please don't give up.

Finally, I'd like to thank the Mayor and Councils of the Hamlet of Arviat, the Hamlet of Rankin Inlet and the City of Iqaluit who have all decided to implement vaccine mandates for entry to their facilities. Your leadership is helping the collective effort to protect Nunavummiut from COVID-19. Matna for encouraging more Nunavut residents to get their COVID-19 vaccination.

Chief Public Health Officer Update:

Good morning.

As announced earlier this week, 1 Nunavummiuq died due to COVID-19 infection Monday night. I would like to take this time to express my condolences to the family who has lost a loved one. This individual was not fully vaccinated and was over 70 years old.

Over the last week, there has been a significant increase in the number of infected individuals in Baker Lake. As a result, schools in Baker Lake will be at half capacity when they open next week. Moving forward we will continue to assess each community on a weekly basis and when appropriate the capacity at schools will be lowered, for at least 1-2 weeks. The goal is to keep the risk of exposure to the same level, or less, than the risk of exposure due to other activities in the community.

One daycare in Iqaluit has closed due to a COVID-19 exposure on site. Testing and contact tracing is taking place.

Details/Limitations:

This information shows the number of doses given in a community as of **January 17**, **2022**. The percentage of vaccine administered is vaccine administered divided by the Nunavut population estimate for 18 and older.

Territorial totals for doses are an accurate summary. The community level data is under review to ensure appropriate attribution. Community totals will be adjusted as needed. This may lead to minor fluctuations in the percentages by community.

Doses are typically attributed to the community in which they are administered.

Total doses given will include residents and non-residents, including rotational workers.

Multiple communities represent individuals who received doses in two separate communities, or in communities that are not their place of residence.

An individual may have received dose 1 and/or dose 2 outside of their community of residence.

This does not account for people who may have been vaccinated partially or fully out of territory.

A high percentage in one community does not equal herd immunity. There is no established or defined percentage of what herd immunity is for COVID-19. Whatever herd immunity may be it cannot achieved with current vaccine approvals (e.g. no vaccine available for children under twelve).

Dose numbers are from the Department of Health's Meditech system.

Eligible adults in community are defined as the number of individuals 18 and older as per the 2020 population estimates.

The community population estimates are "non-official" since they are not based on components of population growth (births, deaths and migration). They should be used with caution.

In person and walk-ins have been suspended for Kinngait office for non-emergency situations.

Closed /Cancelled/Suspended services:

Kinngait office is closed.

Department of Education Services

New developments in your programs/services:

As advised by the CPHO, schools will reopen to students at either 100% capacity or 50% capacity next week, depending on the COVID-19 situation in each community.

As stated by the CPHO today, beginning on January 24:

- Schools in Iqaluit, Kinngait, Arviat, Rankin Inlet, Cambridge Bay, and Baker Lake will open at 50% capacity unless otherwise advised by the CPHO.
- Schools in all other communities will open at 100% capacity.
- Schools will communicate directly to students and families regarding their status and cohort plans.
- If parents are not sure when their student is returning to class, they should contact their student's teacher.

Ongoing services:

<u>FANS</u>

The FANS office continues to process payments for students who have submitted their Student Enrollment Form (SEF).

K-12 Schools

January diploma exams for Nunavut students have been cancelled. Students who were scheduled to write a diploma exam in January 2022 will receive an exemption and their school mark will stand for 100% of their overall mark.
